

**CONTRACT FOR SERVICE to DATABEAST INC**  
**As a Consultant to Clients of DATABEAST INC**  
**by BONZE ANNE ROSE BLAYK Acting as Secretary of DATABEAST INC**

I, BONZE ANNE ROSE BLAYK, aver my readiness to be available as Secretary of DATABEAST INC to the same 24x7x365 standard pertaining throughout my history with DATABEAST INC so as to be able to respond on a real-time basis to crises or unexpected demands requiring prompt attention, and restate my commitment to sustain our educational and cultural mission in Internet Publishing and other endeavors.

**1.0 SERVICES AND CONSIDERATION PROVIDED THE PARTIES TO THIS CONTRACT**

In return for the valuable consideration which may ultimately be provided BONZE ANNE ROSE BLAYK as a shareholder in DATABEAST INC (hereinafter referred to as DATABEAST), BONZE ANNE ROSE BLAYK (hereinafter referred to as CONSULTANT) promises to to perform up to five (5) presentations per week as a consultant under the supervision of a third-party agency, QUVUS CONSULTING AND MARKETING (hereinafter referred to as QUVUS C&M).

- 1.1 DATABEAST shall in turn make best efforts to profit the corporation through these presentations by providing for their promotion and management through the designated agent for this undertaking, QUVUS C&M. CONSULTANT stipulates that QUVUS C&M shall be retained as the subcontracting agency providing Consulting, Marketing, and Event Management services for these presentations, as the sole trusted provider of such services;
- 1.2 These presentations are to be performed by CONSULTANT in her role as officer and Recording Secretary of DATABEAST and a specialist Spiritual Consultant on subject areas offered in the attached document, Exhibit A: "barmayden AnneRose Blayk - Spiritual Consultant - INTERACTIVE BACKGROUNDING TOPICS v2.0," with the understanding that further topic areas may be developed and advertised in collaboration with QUVUS C&M;
- 1.3 Some discussions relating to these topics may involve sharing of confidential information related to the projects and missions of either the client or DATABEAST, and thus should be expected to proceed - in private presentations - under legal protection as an exchange of privileged corporate information, which must be kept in confidence by both parties;
- 1.4 Time devoted to performing presentations shall total fifteen (15) hours or less per week, with the expectation that another fifteen (15) hours of research and other preparation will be required for these presentations, with a total time commitment of up to thirty (30) hours per week, not to be

exceeded in toto except when comfortable accommodations acceptable to CONSULTANT are afforded as a vacation perquisite apposite to conference arrangements or under extraordinary circumstances.

## 2.0 TRAVEL

When overnight stays and/or extensive travel are required to perform a presentation, payment for such expenses by DATABEAST or QUVUS C&M is acknowledged by CONSULTANT as adequate reimbursement for any time spent beyond the contracted 15 hours per week, so long as such off-duty time does not exceed her total service obligation of 30 hours per week and do not qualify as vacation perquisites under the contract arrangements between CONSULTANT and QUVUS C&M.

- 2.1 QUVUS C&M shall be mandated in their contract with DATABEAST to supervise reimbursement for CONSULTANT through DATABEAST for reasonable expenses incurred thereby, such as transportation, food, and beverage expenses, on a monthly basis following submission of expense receipts and their validation by QUVUS C&M, and QUVUS C&M shall be enabled to perform the accounting functions necessary to this task through systems under the control of DATABEAST.

## 3.0 DURATION AND TERM

The term of this Agreement shall be for five (5) years and CONSULTANT grants to DATABEAST the option to extend the term of this agreement for another (5) five years under all the terms and conditions hereof, and subsequently for each five (5) year period, if both parties agree to extend contract. Said options shall be exercised automatically unless thirty (30) days prior to the end of the then current term either party gives the other, written notice to the contrary.

- 4.1 This Agreement may be terminated by either party, by written notice as provided below, if CONSULTANT is found to be suffering from a total disability or QUVUS C&M rendered incapable of providing services.
- 4.2 This Agreement may be terminated by DATABEAST, by written notice as provided below, if QUVUS C&M files notice with DATABEAST that CONSULTANT has failed to comply with the standards agreed upon in their separate agreements governing provisioning of CONSULTANT's services.
- 4.3 Notice of such termination shall be given by certified mail addressed to the addressee at the addresses listed below unless such have changed and all parties have been given notice of the new address. Such notice of termination must be received by all parties no later than two (2) weeks following the occurrence of any event described above.



Failure to give notice as aforesaid shall constitute a waiver of the right to terminate based upon the happening of such prior events.

#### 4.0 GOOD CONDUCT



Agent accepts insistence of Artist on the imposition of the constraints on her behavior specified in sections One through Five, and has preserved intact the language provided by Artist, who will acknowledge her responsibility for initiating these requirements by initialing each item.

Agent understands that individual Artists may struggle in expressing their messages in a responsible fashion according to their religious or philosophical beliefs, and will require assistance in meeting their own standards; Artist accepts that all subsequent requirements in this document are made in the spirit of maximizing her potential as a Spiritual Consultant in Agent's capacity as an appearance manager. Artist agrees that Agent is free to advertise all these conditions.

and correspondingly insist that while performing duties related to engagements Artist shall conform to her offer using best available technology for this purpose, the CB3000. [See Exhibit 4]

5) Honesty in Artist Representations to Agent and Clients

Agent accepts the declaration of Artist that she is a Disciple of Christ, and that she strives to fulfill her corresponding duties of stewardship and honorable witness in a responsible manner in compliance with the wishes of her husband, Lenora Quvus.

Artist has represented herself in prior negotiations as "attracted to the practice of Vajrayana Buddhism under the general principle that as an informal practitioner I can dismiss elements inconsistent with my submission as a Disciple of Christ
