We are the lawyers for the Centre for Addiction and Mental Health ("CAMH") and Dr. Kenneth Zucker. It has recently come to our clients' attention that there is false, unlawful and defamatory information posted on your website, www.lynnconway.com which is linked to the University of Michigan website at http://ai.eecs.umich.edu/people/conway/conway.html

Your website contains very serious false and defamatory allegations of criminal conduct and sexual abuse by Dr. Zucker. These allegations clearly exceed the limits of free speech and public discourse.

Specifically, our clients are concerned with a January 17, 2009 posting on your "Trans News Updates", found at http://ai.eecs.umich.edu/people/conway/TS/News/News.html and which states the following:

01-17-09: Organisation Internationale des Intersexués (OII): "The self-proclaimed experts on intersex: Zucker and Lawrence", by Curtis Hinkle
"I am sure that many intersex people were aware that the APA had brought out a booklet on intersex. However, I am not sure that many understand how problematic it is to many intersex people to see some of the following names associated with this booklet: Margaret Schneider, Walter O. Bockting, Randall D. Ehrbar, Anne A. Lawrence, Katherine Louise Rachlin and Kenneth J. Zucker. At first glance, the booklet seems apparently harmless. However, that is what's so clever about it. It's a way for the Clarke/Northwestern clique to get their nose under the (intersex) tent and then later "come on in"."

We note that you have created a hyperlink for "Kenneth J. Zucker", and upon clicking the link, leads the reader to the website at

http://www.intersexualite.org/WPATH.html and titled "Open Letter to President of WPATH from OII - (Sent 28 May 2008)", where the following statement is found near the bottom of the page:

"OII received communication from an individual that alleged that as a child Zucker had sexually abused her. OII reported this to the proper authorities, including many members of WPATH."

A copy of your website postings and links to the defamatory material, with the defamatory words underlined, is attached hereto as "Appendix A".

As stated above, the allegations contained in this posting are false and highly defamatory to Dr. Zucker. Furthermore the posting has resulted in irreparable harm to his professional and personal reputation. These are very serious allegations of criminal conduct that exceed the limits of free speech and public discourse.

It is our clients' position that it is wholly inappropriate for a professional such as yourself to publish such defamatory material and furthermore, to link it to an institutional network such as the University of Michigan network. Please be advised that we have also notified the IT User Advocate at the University of Michigan of this defamatory posting.

Please be advised that as the owner and administrator of your website, and by your own admission, the "compiler and editor" of the "Trans News Updates", including the aforementioned defamatory statements, you are liable for perpetuating the damage caused by such serious and defamatory allegations to Dr. Zucker's reputation. Furthermore, you are liable for additional aggravated damages for the malicious nature of your conduct.

Please note that it is not our clients' intention to stifle free speech on issues that are of public interest or to infringe on matters of academic freedom. Our clients are not attempting to stifle legitimate and good faith discussions on their work as our clients acknowledge that their work, and the work of the Gender Identity Clinic, is the subject of often vigorous debate and criticism. However, the nature of your conduct exceeds the limits of such valid commentary on matters of public interest and constitutes a serious personal attack on Dr. Zucker.

The defamatory statements that you have posted have lowered and will continue to lower, the reputation of our clients to the world at large. In the circumstances, our clients insist that you immediately take steps to remove the defamatory material from your website – specifically, we request that you remove any links on your website to the website

http://www.intersexualite.org/WPATH.html which contains the defamatory statements.

Please confirm receipt of this libel notice immediately and advise us immediately of what steps you will take to have this defamatory material removed from your website.

My goal for this website is to illuminate and normalize the issues of gender identity and the processes of gender transition. This project began in the year 2000, as I struggled to "come out" about my past to my research colleagues. I wanted to tell in my own words the story of my gender transition from male to female three decades earlier, in 1968, and then of being outed 31 years later in 1999, while living quietly and successfully in "stealth mode".

Since beginning work on this website, I've come into contact with ever growing numbers of people concerned with gender issues. I've interacted via e-mail and in personal meetings with large numbers of people who are transitioning or who have transitioned. Given the still-remaining social invisibility, ignorance

and superstitions about gender conditions, I've felt a strong need to provide whatever information, encouragement and hope that I can to help others who are struggling with these issues.

As a result of my contacts with thousands of TG/TS/IS people over the past few years, this website has evolved into a major informational and support site for <u>transgender</u> and <u>transsexual</u> people. The site now reflects years of field work and empirical research, and intensive efforts at framing and writing up the resulting observations regarding this previously almost invisible, highly stigmatized minority about which many superstitions still prevail.

This work has been conducted in the style of an investigative journalist who herself is embedded in the "war zone" she is covering. These investigations, carried out in an arena swirling with new shifts in existing paradigms of thought, have been continually shaped and guided by very close interactions with hundreds of people who are themselves very experienced in these issues. Many of these individuals have shared in the creation of this website, by contributing valuable observations and practical information about gender transition, and by sharing keen insights and wisdom that they've gained from their own personal experiences.

The website is informal in structure, and is still rapidly evolving as new ideas and information become available. I begin by first telling my own story, as best I can. That story, of someone who underwent gender transition earlier in life, illustrates that such transitions can turn out rather well in the long term. The story also provides personal vignettes relevant to the gender identity sections of this website:

The site also links to webpages containing photos and stories of over 200 other people who've undergone complete gender transitions (both MtF and FtM). These many additional true-life "success stories" can provide encouragement, hope and role models for others, especially for the many young transgender and transsexual people who often feel so much fear and desperation about their futures. Experienced-based knowledge and real-world role models can go a long way towards easing the fears of these young people, helping them more confidently confront the challenges ahead of them, and illuminating pathways they can follow to build a full and joyful life:

We can also help society see us as the human beings we truly are. In the process we can enable more and more people to live fuller and happier lives in an increasingly inclusive, harmonious society.



Important updates on the Zucker-Dreger attacks on trans critics: In July '07, Ken Zucker, editor of the Archives of Sexual Behavior (ASB), subverted that journal as a propaganda rag in defense of editorial board members Bailey, Blanchard and Lawrence (BBL). He did this by announcing and pre-publishing Alice Dreger's one-sided history of the Bailey book investigation. Zucker promoted Dreger's hit-piece as if it were an independent scholarly work, devoting the entire June '08 ASB to Dreger's defense of Bailey. Ardent Bailey supporter Ben Carey followed with a New York Times article on 8-21-07 in which Dreger portrayed Bailey as a great scientist under siege for 'telling the truth'.

Determined to stop criticism of Bailey, Dreger went on to launch e-mail attacks and threaten the academic career of graduate student Joelle Ruby Ryan who had proposed a women's study conference panel on transphobia in academe (see Élise Hendrick's commentary, Lynn's comments and this article). Dreger's attempt to prevent Joelle's panel backfired. It was held as scheduled on June 21, 2008 (see flyer and handout), and produced powerful essays that further exposed Bailey and Dreger (see detailed report at this link) including Élise's essay on the odd form of 'academic freedom' claimed by Bailey and Dreger and Andrea's essay "Fair comment, foul play". Videos of all the presentations are posted on YouTube. See also the prestigious Point Foundation 's mention of Joelle's panel at this link.

Julia Serano has published an exposé of Dreger 's effort to resurrect Bailey's disgraced career, and her book Whipping Girl:

A Transsexual Woman on Sexism and the Scapegoating of Femininity provides the context for understanding these events.

For an overview of BBL pseudo-science, see "Science and Ideology: The Blanchard-Bailey-Lawrence Model of Transsexuality, by Élise Hendrick and "The Bailey Affair, Again" by Joan Roughgarden. For a deconstruction of Carey's Times' article, see this essay by Élise Hendrick. Dreger's scholarship was further questioned in June '08 in peer commentary papers highly critical of her work.

Important updates re Zucker, the APA and the DSM: An exposé of <u>Zucker's reparatist treatment</u> of gender-variant children, "<u>But For Today I Am A Boy</u>" (<u>Français</u>), was published in the <u>Torontoist</u> on May 9, 2008. <u>National Public Radio broadcast a heartbreaking documentary on May 8-9, 2008 contrasting Zucker's <u>decades-old reparatist methods</u> to more <u>modern treatment protocols</u>. <u>Organisation Intersex International (OII) then raised important questions</u> about Ontario's sponsorship of Zucker's work. See also <u>OII's Open Letter to WPATH</u></u>

In a further development, Zucker was selected to lead the revision of the Amer. Psychiatric Association's section on 'sexual

and gender identity disorders' in the Diagnostic and Statistical Manual of Mental Disorders (DSM) even though he's known to be a trans-reparatist. With Zucker thus empowered, there's little chance for removal of GID from the DSM, and trans people will likely be stigmatized for another decade as being mentally ill even after transition. See the National Gay and Lesbian Task Force (NGLTF) press release protesting Zucker's DSM selection. The huge scale of the protest was made even more visible in a petition against Zucker's DSM selection that gained over 9,500 signatures (noticia en español). See also the petition protesting Ontario gov't support of Zucker's work. (more, more), and the petition in protest of Zucker's key role in a UK conference on adolescent transitions.



Open Letter to President of WPATH from Oil - (Sent 28 May 2008)

Dear Stephen Whittle,

Sophia Siedlberg and I are writing to you on behalf of the Organisation Intersex International about a very disturbing problem associated with WPATH and what appears its total lack of intersex input and representation. We in Oll have worked very diligently to prove that we are allies with your membership. We therefore are concerned that we have been ignored and perhaps even intentionally harmed by WPATH.

There is a committee in WPATH with the following name:

WPATH Committee on **Disorders of Sex Development**One of the members of this committee is **Ken Zucker**, Ph.D. (Canada).

This is offensive to the membership of OII which is the largest intersex organisation in the world and also a Canadian organisation. We are very concerned that Ken Zucker is the Canadian representative on a committee devoted to intersex issues using the extremely stigmatizing term "disorders of sex development". It is important to point out that more and more Canadians, many of whom are in close contact with OII, find that Ken Zucker is an embarrassment to Canadians and many are very upset about abuse of gender variant children being subsidized by publicly funded dollars.

Also, there is no intersex membership on this committee. There was absolutely no discussion with intersex people that we are aware of about forming this committee and we would like to know why this committee is even

a part of WPATH.

If you watch the following video, you will see why many intersex people are not interested in having Zucker be part of a committee devoted to these issues.

Does WPATH approve of referring to people with intersex variations as having a "disorder of sex development"? Does WPATH approve of Ken Zucker's membership on this committee despite that fact that we in the intersex community are not aware of any attempt on his part to inform himself of what the majority of intersex activists feel about these issues?

I would like to know if this is the image that WPATH wishes to give to the world and I would like to know what

overall membership feels about stigmatizing intersex people and putting Zucker on this committee. Would you please let the Organisation Intersex International know how the membership feels about treating intersex people and our issues in this manner?

We hope that this matter can be resolved in a manner that does not cause serious damage to the intersex community and all the intense work we have done to be inclusive of trans issues.

Follow up:

Oll has yet (31 July 2008) to receive any serious response from Stephen Whittle concerning the specific Issues raised in this letter, nor the serious allegations and other ethical issues concerning Zucker that the president of Oll shared with many members of WPATH who were members of the Gender ID Coalition which Stephen Whittle was also a member of.

Oll received communication from an individual that alleged that as a child Zucker had sexually abused her. Oll reported this to the proper authorities, including many members of WPATH.

Please note:

Oll did eventually receive an email from Stephen Whittle which appeared initially to answer some of the questions raised by members of Oll. And it also appeared that Stephen Whittle was being polite and reasonable. However, later on Stephen Whittle said in his blog that he was both angry and felt the discussion with Oll was very hostile. For us the problem appears to be the inconsistency with which Stephen conducted himself in this debate, being civil with us at first, but later taking a very unpleasant stance in his blog and in emails to various individuals who challenged him on some points. We are concerned because Oll and intersex activists feel they are being attacked by Stephen Whittle for asking these questions about Zucker. The president of Oll has decided not to communicate any further with Stephen Whittle.

Oll considers any allegation of child sexual abuse to be very serious (see bold print above). We regret that our attempt to inform some people about Zucker and issues affecting the intersex community is met with what we percieve to be intimidation.

I knew an Andrea Brown in the early days of Press for Change, she was out, an activist and a kind, sensible, realistic young woman. I presume you are not her. But, to the point, my side of the argument was presented to Oll at the end of June, within 3 weeks of reading their mail.

What is there not to believe in my reply - it is a simple outline of facts.

You really are becoming a disgraceful pariah, feeding off other people's miseries, and ultimately causing harm to those you profess to support. And you are vicious to boot.

This is not a threat, this is a promise: if you once again repeat, in any forum, yours', Sophia Seidlberg's or Oll's defamatory lies and allegations, or anything else that is untrue or defamatory about me, I will sue you for defamation, even if I have to hunt you down to the ends of the earth. And I promise that - speak the truth and you have nothing to fear, continue these lies and I will use the law to obtain what is right and truthful.
