- admitted 4/4/03 - ~~was~~ "wild appearing" "talking to walls, illogical thought processes, disoriented to me & place" irrelevant responses, talking to unseen persons, incoherent statements, "bizarre sounds"?

Under the influence? "possible" smoking MJ

Behavior 4/6/03 "grapped her by the hair swung her around" refusing to keep clothes on, had to be redirected

F> Interaction w/ peers - <sup>one who</sup> smoked MJ a lot, they have drugs in common

> One meeting -! "avoidant" "doesn't want me to know what he's thinking"

Ambulance - screaming & shaking

M) Dependence, Bipolar/psychotic "he was very flamboyant" psychotic reactions to some substance

> BP "mood states changed to some other BP symptoms - preoccupation w/ being mistreated, pressured speech, visibly angry,"

 "important car will treat my mania"

Olanzapine is anti-maniac

"small as a pimple" feet hurt like HELL!

> "Instruct w/ MH without feelings of persecution"  
F > "running around w/ clothes off in the streets" FALSE

if predisposition to mania, bad. possibility in this case

Ward restriction - team determination

appropriate because "he remains untreated" dangerous - smokes MJ, likely will become psychotic, depressed, or manic

\* H2 > "When we asked 'about the trailer'"

Trailer preoccupation w/ Silence

[IDENIED anger as a factor ~~it~~ she says it was!]

"And his thinking is illogical when we asked what caused him to come back - when admitted, antibiotics prescribed were refused"

saw 4/4, ~~4/7~~, 4/11, 4/10, 4/24

40 minutes "I don't clock watch"

"stood behind nurse's station"

> I am "guarded & evasive" about persecutory "delusions"

other admissions AP at Cornell OK!, not familiar w/ TCMH records

1993 Imace OK!

RFU 1998

"no substantive therapy" no, violent, not threatening

"another problem is he will not let me evaluate his thinking"

"Prozac Trazodone, MCPP,"

"he will not talk about bipolar" !!!

"sepsis never diagnosed"

"not a little infection like that"

> B prescribed med - Trileptal - (fully explained why I refused.) "briefly reviewed Tompkins County materials"

prescribed Zyprexa? FALSE  
refused drug screens

extension recommended in March "resurgence of anger"  
recommendations to continue "observation"

> "no way to make progress without cooperation"

F> "mistake that there could have been an interaction between medications [that caused the 1997 psychosis

"Forensic Bureau" recommended transfer to Elmira!

> never reviewed Linda's notes! "general consensus with the non-compliance"
